2. **Board will review the application and notify the applicant.**

- **New Members or Returning Members paying Early Bird cost:**
Market fee is \$150 per space for a season, with additional \$5 per market/ per space attended. The \$5 fee will be collected on site at each market.
- **Alternate Season payment option:** Applicants may instead choose to pay a total fee of \$280 for an entire season, this covers the membership fee and the stall fees for all market dates.
- **With each of these options: If you are requesting a double stall space, you will need to double the costs.**
- **Returning vendors that are paying the "Late Membership Fee" and wish to use the Season payment option, you will need to pay \$280.**

3. **New Members:** Upon positive approval from the board, make checks payable to "Somerset County Farmers Market Inc." and bring it with you to the **Spring Group Meeting (date TBA)** or mail it to the address above.

4. **Market space will only be considered when checks are received.** (Fee must be made before you may attend Market)

5. Returning Vendors may simply update any necessary information, sign, and send with payment to address above.

6. **Voting Rights:** Each member of the Corporation shall be entitled to the following voting rights: Each member shall be entitled to vote in the election of Directors at the annual meeting and to cast one vote for each Director to be elected. Cumulative voting shall not be permitted. Each member shall be entitled to one vote on each other matter to be voted on by the members at any annual or special meeting of members of the Corporation.
